GIC HIMSS Scholarship Program 2023-2024

Purpose

To provide financial assistance and recognition to qualified students in accredited programs in health management, health information technology, management programs with a health focus, or technology programs with a focus in healthcare information technology.

Objective

Provide two (2) scholarship awards to worthy candidates

Program Structure

Two \$2,500 scholarships will be offered to selected students: one in a graduate program (to include Masters or Doctorate) and the other in an undergraduate program.

Scholarships will be offered to students in the following types of programs:

- Health information management/technology
- Health management, with a focus in information management/technology
- Clinical programs with a focus in information management/technology
- Health science programs with a focus in information management/technology
- Business management programs with a focus in health information management/technology
- Management science programs with a focus in health information management/technology
- Other types of degree programs which emphasize health information management/technology

Eligibility

Participation is open to students who meet the following criteria:

- Currently enrolled in a Healthcare Information Technology (HIT) related undergraduate, master's or post-graduate degree program at an accredited college or university (certificate programs are not eligible for award)
- Reside in Illinois within GIC HIMSS chapter boundaries
- Have a minimum Grade Point Average of 3.0

Have completed at least one quarter or semester in their HIT related degree program.

Application Process

Eligible students should complete the following steps by midnight U.S. Central Standard Time on Sunday, November 17, 2022.

- 1. Combine the following documents in a single PDF:
 - A most recent transcript(s) indicating a Grade Point Average of 3.0 or higher. Unofficial transcripts are acceptable.
 - o Two letters of recommendation from superiors for whom the candidate has worked with and/or college professors with whom the candidate has studied under.
 - o A short essay (500 750 words, double-spaced) that addresses both of these questions:
 - In recent years, artificial intelligence (AI) has gained significant attention and adoption in the healthcare industry. Discuss a major challenge or opportunity that AI can address in the field of healthcare.
 - Explain how you envision the role of AI professionals like yourself in leveraging AI to make a meaningful impact in healthcare
- 2. Complete the <u>online program application</u> and attach the PDF that includes your transcript, letters of recommendation, and essay.

Evaluation Criteria

A panel of GIC HIMSS members will evaluate each candidate according to these criteria:

- Meets grade point criterion
- Quality of recommendations o Provides specific examples of the candidate's distinctive qualities, attributes, and potential
 - o Provides examples of the candidate's professional and academic growth
- Quality of candidate's essay o Answers both questions with insightful reasoning, persuasive examples, and a unique perspective

Award Recognition and Conditions

Scholarship recipients will be formally recognized at the Career Development Event in Spring 2024, on the GIC HIMSS website, in newsletters, and during other in-person or virtual events.

Scholarship recipients are required to serve as a volunteer on the GIC HIMSS Professional Development Committee from January – December 2024. Meetings are held monthly via conference call.

- November 17, 2023 Applications due at Midnight U.S. Central
- December 2023 Application review and recipients selected
- December 2023 GIC HIMSS Board approves scholarship winners
- January 2024 Award recipients and candidates notified by email/phone call.
